

## 2016 "Car for a Cause"

Between October 1st and November 30<sup>th</sup> 2016 you can nominate a deserving family or individual to win a vehicle by submitting an official entry online. You may also print an official entry form from the website or complete the entry form at any participating San Diego Auto Repair Care shop explaining why the family or individual they are nominating deserves a vehicle.

Website visitors can nominate their friends, neighbors, anyone they personally know who deserves and would be in need of a used vehicle in great condition. NO Self nominations will be accepted..

Submissions must be filled completely on an official entry form. No additional documents will be accepted.

This contest is open to California residents only living in the San Diego area and surrounding cities.

Entries must be delivered in person to any San Diego Auto Repair Care shop no later than 5PM on Wednesday November 30<sup>th</sup> 2016.

Winners will be selected by a panel of scorers on or around December 9<sup>th</sup>, 2016 and notified on or before December 12<sup>th</sup>, 2016.

\*Vehicle transfer will occur at an event on or around December 18th 2016 (Note, News / media may be present) Vehicles not claimed per contest rules after 30 days will be awarded to a runner up contestant.

Contest Name: Enter someone to win the "Car for a Cause" contest (the "Contest")

B. San Diego Auto Repair Care Group will give away (selected vehicle) to a deserving San Diego area residents or non- profit agencies in association with the "Car for a Cause" entry form. Submit an official entry form found at [www.sandiegoautorepaircare.com](http://www.sandiegoautorepaircare.com)

OR at a participating shop, describe why the nominated person is deserving of a vehicle. All submissions must be submitted no later than 5PM on Wednesday November 30<sup>th</sup>, 2016. No additional documents will be accepted. Entries will be judged by a panel of San Diego Auto Repair Care members or partners.

The contest winners will be notified via telephone on or before December 12<sup>th</sup> 2016. Prize will be delivered to the winner at an agreed upon date, on or around December 18<sup>th</sup> 2016. Media outlets may be invited to attend the delivery event. Vehicles not claimed in 30 days per contest rules will be awarded to a runner up contestant.

C. How to participate: Participants should log on to [www.sandiegoautorepaircare.com](http://www.sandiegoautorepaircare.com) and follow the link to the promotions page. Entries must be submitted on-line or in person to a participating San Diego Auto Repair Care shop.

2. **Prize.** The prize awarded to the eligible winner will be a vehicle which will be determined as fair market value at the time the prize is awarded.

Prize is not transferable, redeemable for cash or exchangeable for any other prize.

If a winner cannot be contacted, disqualified or refuses the vehicle for any reason, the Group reserves the right to determine an alternate winner or not to award that winner’s prize, in its sole discretion.

3. **Eligibility and Limitations.** Participants and winner must be a U.S. residents at least 18-years old as determined by the Company and reside in the state of California. The Company/group reserves the right to refuse to award a prize to or on behalf of any minor. Only one (1) entry per person/family. Only one (1) prize per household for the Contest. Members of the San Diego Auto Repair Care Group, the Contest’s participating sponsors and their advertising agencies, and members of the immediate family of any such persons are not eligible to participate and win. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, cohabitation or other family extension, and any other persons residing at the same household whether or not related.

or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by San Diego Auto Repair Group.

7. **Taxes.** Any valuation of the prize(s) stated above is based on available information provided to the Company, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize(s) and paying any expenses associated with any prize which is not specifically provided for in the official rules. Each winner must provide the Company with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from the Company will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.

10. **Compliance with Law.** The conduct of the Contest is governed by the applicable laws of the United States of America, which take precedence over any rule to the contrary herein. Sponsor(s) shall follow the applicable laws for conducting contests, including notice to the state attorney general or consumer affairs office, posting of a prize bond, furnishing lists of winners, providing specific written information about the Contest, etc. as required by local and state laws.
